INVITATION FOR NOMINATIONS TO SERVE AS DEPUTY CHAIRPERSON OF THE PELINDABA PUBLIC SAFETY INFORMATION FORUM (PSIF)

The National Nuclear Regulator (NNR) is an independent regulatory authority established as a juristic person in terms of section 3 of the National Nuclear Regulator Act (Act No. 47 of 1999) to regulate the safe use of nuclear and radioactive materials in order to protect persons, property and the environment from the potential harmful effects of radiation in South Africa.

In terms of the National Nuclear Regulator Act, the NNR's regulatory mandate involves the following priority areas:

- provide for the protection of persons, property and the environment against nuclear damage through the establishment of safety standards and regulatory practices;
- exercise regulatory control related to safety over:
 - the siting, design, construction, operation, manufacture of component parts and decontamination, decommissioning and closure of nuclear installations; and
 - vessels propelled by nuclear power or having radioactive material on board which is capable of causing nuclear damage, through the granting of nuclear authorisations.
- exercise regulatory control over other actions, to which this Act applies, through the granting of nuclear authorisations;
- provide assurance of compliance with the conditions of nuclear authorisations through the implementation of a system of compliance inspections;
- fulfil national obligations in respect of international legal instruments concerning nuclear safety; and
- ensure that provisions for nuclear emergency planning are in place.

The South African Nuclear Energy Corporation (Necsa), as holder of nuclear authorisations for the nuclear facilities on the Necsa Pelindaba site, is required as per Licence Condition 26 and the provisions of Section 26(4) of the National Nuclear Regulator Act, to establish a Public Safety Information Forum (PSIF) to inform the persons living in the municipal area in respect of which an emergency plan has been established on nuclear and radiation safety information related to the nuclear installations.

A further provision in accordance with Regulation R968 of 12 September 2008, is for the PSIF to have a Chairperson and Deputy Chairperson who shall be appointed by the NNR Board of Directors, from nominations received from members of the public living in the relevant municipal area. The Chairperson and Deputy Chairperson will serve for a period of two years and perform their duties without financial compensation. The current term for the Deputy Chairperson of the Pelindaba Public Safety Information Forum expires on **31 October 2021**.

Members of the public are hereby invited to submit nominations for the Deputy Chairperson of the Pelindaba Public Safety Information Forum.

Please take note of the following requirements for submitting nominations:

- Only written nominations will be considered (Hand written or typed);
- A declaration of acceptance by the nominee must accompany the written nomination;
- A copy of the nominees current CV;
- Certified copies of Identity documents for the nominee and the person making the nomination; and

The selection criteria includes, but not limited to the following:

- Submission must comply with the requirements as advertised;
- Nominee must reside in the relevant municipal area as per regulation;
- Experience in community based initiatives; and
- Attendance of Public Safety Information Forum meetings.

Go ya ka National Nuclear Regulator Act (Act No. 47 of 1999), molao wa taolo wa NNR's e ama dintlhakgolo tse latelang:

- go tlamela tshireletso ya batho, phatho le tikologo kgathanong le tshenyho ya nuklea ka go tlhomiwa melao e laolang boemo ba go diragatsa tshireletso le melao e laolang tiragatso;

 - go baakanya, go dira, go aga, tiriso, go dira dikwarolwana le go phepafatsa gone, go tlhatlhamola le go tswala ga nuklea tse di tsentshitsueng; le
 - diketswana tse tsamaisang ke matla a nuklea kgotsa a naleng marang a kotsi mo seketswaneng a ka kgonang go thagisa tshenyego ya nuklea, ka go letlelelwa nuklea.

- go phetagatsa maikarabelo a ditshaba ka bophara ka mabapi didiriswa tsa molao tsa ditshabatsaba mabapi le tshireletso ya nuklea; le
- go netefatsa tlamelo ya go bakanya thusa ya potlako e diragala.

The South African Nuclear Energy Corporation (Necsa), motshwari wa nuklea ya tsetlelelo ya dikago tsa nuklea mo mafelong a Pelindaba mafelong, fela jaaka go kopilwe laesense ya maemo a molawana wa masomeamabeditataro (26) goya ka molawana wa go ya ka molawana wa 26(4) wa National Nuclear Regulator Act, go tlhomiwa Phatlhalatsa Molaetsa Wa Pabalesego (PSIF) go begela batho ba ba nngang mo mmasepala mabapi le maano a molaetsa wa thoganyetso o tlhomilwe mo pabalesego ya molaetsa wa nuklea le marang a tsamaisanang le go tsenywa ga nuklea.

Molawana o mongwe gape go ya ka molao R968 wa lesome le bobedi wa Lwetswe, ke wa PSIF go ba le Mothusa-Motlhankedi Wa Modulasetulo o tla tlhophiwang ke Boto ya Maekedi NNR, mo ditlhopheng tse filhetsweng go tswa go maloko a setshaba ba ba nngang mo lefelong la mmasepala o tshwanelang. Mothusa-Motlhankedi wa Modulasetulo o tla direla mo nakong ya dingwaga dile pedi le go dira tiro ya bona kantle le go duelwa. Nako ya jaanong ya Mothusa-Motlhankedi wa Modulasetulo Wa Sethlopha Sa Go Pha thalatsa Molaetsa Wa Pabalesego Wa Pelindaba e fela ka kgwedji ya Diphallane ale some a mararo nngwe kete pedi some a mabedi le bongwe.
