Dear Stakeholder,

Update on the National Nuclear Regulator (NNR) Public Hearings for Eskom Holdings SOC Ltd (Eskom) application to extend the operating life of the Koeberg Nuclear Power Station (KNPS) by 20 years.

I am pleased to clarify that the NNR will hold two sets of public hearings for the Koeberg Long Term Operations (LTO) licence application. The first set of hearings will take place on 3, 10 and 17 February 2024. A second set of public hearings will be held between May and June 2024 upon receipt of the seismic risk analysis report and other information supporting the LTO application.

For 3, 10 and 17 February 2024, interested and affected parties are welcome to submit their written submission 24 hours before the scheduled hearings i.e. if a participant intends to attend the public hearing on 3 February 2024, they can submit on 2 February 2024 before 09h30. To register to make oral representation at the public hearing, the NNR will continue to accept registrations until 72 hours before the scheduled hearings i.e. if a participant intends to attend the public hearing on 3 February 2024, the due date for registration will be 31 January 2024 at 09h30.
