- Democracy transparency and consultation


### Civilian exposures

- May 2013 A batch of metal-studded belts sold by online retailer <u>ASOS.com</u> were confiscated and held in a U.S. radioactive storage facility after testing positive for <sup>60</sup>Co.<sup>[77]</sup>
- April 2010 INES level 4 A 35-year-old man was hospitalized in <a href="New Delhi">New Delhi</a> after handling radioactive scrap metal. Investigation led to the discovery of an amount of scrap metal containing <a href="60Co">60Co</a> in the New Delhi industrial district of <a href="Mayapuri">Mayapuri</a>. The 35-year-old man later died from his injuries, while six others remained hospitalized. <a href="[71][72]">[71][72]</a>
- December 2001 Three woodcutters in the nation of <a href="Georgia">Georgia</a> found two warm canisters near their camp and spent the night beside them...... The woodcutters started showing symptoms of <a href="radiation sickness">radiation sickness</a> within hours, and were subsequently hospitalized with severe radiation burns. <a href="Id=1">[45]</a> The disposal team consisted of 25 men who were restricted to 40 <a href="seconds">seconds</a> worth of exposure each while transferring the canisters to <a href="lead-lined">lead-lined</a> drums. <a href="lead-lined">[45]</a>

### Civilian exposures...

- May 1998 Recycler Acerinox in Cádiz, Spain, unwittingly melted scrap metal containing radioactive sources; the radioactive cloud drifted all the way to Switzerland before being detected.[22][36] (See Acerinox accident.)
- 1999 A road near Mrima Hill, <u>Kenya</u> was rebuilt using local materials later found to be radioactive. Some workers were exposed to excessive radiation, and many residents of the area were tested for exposure. 2,975 metric tons of roadway material were to be dug up to eliminate the hazard. [38]

## Is everything under control?



### National Nuclear Regulator

• The fundamental objective of the NNR is to provide for the protection of persons, property and the environment against nuclear damage through the establishment of safety standards and regulatory practices suited for South Africa. To this end, the NNR provides oversight and assurance that activities related to the peaceful use of nuclear energy in South Africa are carried out in a safe manner and in accordance with international principles and best practices.

## National Environment Management Act 1998 Key Principles

- Precautionary principle that a risk averse and cautious approach is applied, which takes into account the limits of current knowledge about the consequences of decisions and actions;
- Participation to be promoted The participation of all interested and affected parties in environmental governance must be **promoted**, and all people must have the opportunity to develop the understanding, skills and capacity ..
- Access to information / reasoned decisions- Decisions must be taken in an open and transparent manner, and access to information must be provided in accordance with the law.
- Environmental justice must be pursued so that adverse environmental impacts shall not be distributed in such a manner as to unfairly discriminate against any person, particularly vulnerable and disadvantaged persons.

#### 9. FINANCIAL ARRANGEMENTS

9.1 ESKOM is responsible to cover the costs for the establishment, implementation and management of the Plan, insofar as it relates to Koeberg, or any action related to Koeberg, which is capable of causing nuclear damage.

## THE INTEGRATED KOEBERG NUCLEAR EMERGENCY PLAN

- Disaster Management means a continuous and integrated multisectoral, multi-disciplinary process of planning and implementation of measures aimed at:
- (a) preventing or reducing the risk of disasters;
- (b) mitigating the severity or consequences of disasters;
- (c) emergency preparedness;
- (d) a rapid and effective response to disasters;

## Can we know that Koeberg is safe to continue?



FINDING-1: The plant has not comprehensively revalidated the TLAAs [time limited ageing analyses] for concrete structures.

RECOMMENDATION: The plant should consider improving revalidation of TLAAs for concrete structures.
